# BC SNOWBOARD ASSOCIATION Commitment to Fair Play

#### **Purpose**

1. BC Snowboard Association aims to ensure that every participant is treated fairly. To that end, BC Snowboard Association has adopted this *Commitment to Fair Play* and is committed to upholding the positions outlined herein at all times.

### **Position on Equity and Access**

- 2. Equity is the belief and practice of fair and just treatment for all individuals. BC Snowboard Association believes in and promotes, through its programs, the concepts of equal opportunity, inclusiveness, fairness, and honesty. BC Snowboard Association expects the highest standards of moral and ethical conduct from all its athletes, coaches, officials, volunteers, and administrators at every level.
- 3. BC Snowboard Association believes in an environment free from discrimination based on a person's race, color, ancestry, place of origin, political belief, religion, marital status, sexual orientation, physical or mental disability, age, or sex. To be equitable means to be fair, and to appear to be fair.
- 4. Efforts will be made towards raising the awareness and understanding of the equity issue in the snowboard environment.
- 5. Equity does not necessarily mean that all persons must be treated exactly the same. In order to be treated fairly, people may need to be treated differently, including having activities of their choice provided and administered in a fair and unbiased environment.
- 6. BC Snowboard Association has the opportunity to take a compelling leadership position within the sport community in British Columbia by making a clear commitment to equity.
- 7. BC Snowboard Association has created and follows a *Gender Equity Policy*.

#### **Position on Drug Free Sport**

- 8. BC Snowboard Association is committed to the Spirit of Sport. BC Snowboard Association believes that the most effective way to prevent doping in sport is through a long-term commitment to the core positive values of sport. This belief recognizes the negative impact and tremendous pressures on athletes to "win at all costs". Accordingly, BC Snowboard Association attempts to strike a better balance within its sport by encouraging its coaches, officials, parents and others to place more value and importance on the internal rewards associated within snowboard. BC Snowboard Association believes that the athletes' involvement in snowboard should be about the pursuit of sporting and human excellence. Therefore, any pursuit of sporting excellence that undermines the pursuit of human excellence, such as the use of performance enhancing drugs, is totally unacceptable.
- 9. BC Snowboard Association supports this position through endorsing and supporting Canada Snowboard's anti-doping policies and testing procedures.
- 10. BC Snowboard Association has created and follows a *Drug Free Sport Policy*.

## **Position on Rights for Athletes**

- 11. Bill Of Rights for Athletes:
  - Right of the opportunity to participate in sports regardless of ability
  - Right to participate at a level that is consistent with the developmental level
  - Right to have qualified sensitive leadership
  - Right to participate in a safe and healthy environment
  - Right of each participant to share in the leadership and decision making of their sport
  - Right of child athletes to play as children
  - Right to proper preparation in the sport
  - Right to an equal opportunity to strive for success
  - Right to be treated with dignity by all involved
  - Right to have fun through sport

#### **Demonstration of Commitment**

- 12. BC Snowboard Association shall publicly declare that it is an equal opportunity employer and respects the principles of pay equity in relation to paid employees, thereby having equal pay for equal work by either gender.
- 13. BC Snowboard Association shall practice family-friendly work practices such as flex-time, codes of conduct, pay equity, and non-discriminatory interview techniques. BC Snowboard Association will support discussion on further practices as the need arises.
- 14. BC Snowboard Association shall work proactively with provincial and national agencies to identify and eliminate barriers facing women in sport.
- 15. BC Snowboard Association shall use gender-appropriate language and visuals in all written material.
- 16. BC Snowboard Association shall publicly recognize member clubs that make advancements with respect to equity issues.
- 17. BC Snowboard Association shall strive to have both sexes represented on its delegations to external forums and conferences.
- 18. BC Snowboard Association will not solicit nor accept sponsorship from companies that discriminate against identified groups.
